Injuries to a Group Member	All	Variety of injuries including Musculoskeletal injuries, cuts, bruises	3	3	9	<ul style="list-style-type: none"> Participants to stay in minimum of groups of three. In the event of a party member getting injured one person is to stay with the injured member while the rest of the group goes for help. Group leader is to deal with first aid; help is available from the reception. 	2	3	6
Lost Participant	All	Emotional distress	2	3	6	<ul style="list-style-type: none"> Group are told about the site having boundary fences and they are to stay on site. There is no need to go off site for this activity. Younger participants are advised to have adults in the group. The Cryptic Challenge activity cards include a site map. 	1	3	3
Out of Bounds Areas	All	Variety of injuries including Musculoskeletal injuries, cuts, bruises	3	4	12	<ul style="list-style-type: none"> Areas such as staff accommodation, activity and maintenance areas are strictly 'Out of Bounds'. Fences and signs stop visitors from entering these areas along with checkpoint markers not being positioned near these areas. Participants warned there is no need to go into any of these areas. Certain areas of site are locked to prevent access to unauthorised persons. 	1	4	4

Adverse Weather	All	See 'Exposure'	2	3	6	<ul style="list-style-type: none"> Advice is given on what to do in the occurrence of adverse weather. Participants are advised to wear suitable clothing for weather conditions. Refer to 'Adverse Weather' policy. 	1	3	3

Level	Likelihood Factor	Severity Description
1	Very Unlikely	Insignificant – No injury or No First Aid required.
2	Unlikely	Minor – Minor injuries requiring first aid such as cuts, grazes, bruising.
3	Fairly Likely	Moderate – Injuries resulting in up to three days' absence from work.
4	Likely	Major – Injuries resulting in a week or more absence from work, for example broken bones, deep cut etc.
5	Very Likely	Catastrophic – Amputations or Death.

Remaining Risk Level	Description
1-5	Very low, minimal risk, control measures more than adequate
5-10	Low, control measures satisfactory
10-15	Medium, control measures adequate
15-20	High, control measures need further consideration
20-25	Very high, intolerable, stop Job
